Bart Crowder handed out booklets on MABAS system that will help out on mutual aid with IN and IL fire departments. The fire department would like the City Council to let them join this program. Bart stated the program would cost around \$300.00 per year for dues. Councilmember Copenhaver and Councilmember Smith had several questions

and Bart and Garth answered the questions after a discussion. Councilmember Smith feels the Fire Department should go ahead and get more information and bring to the next council meeting on October 21, 2024 or November 4, 2024.

This week is fire prevention week and the Fire Department is distributing smoke alarms that will be installed by the fire department and they are available all year just not the month of October. The Ham and Bean dinner will be October 26, 2024 at the Fire Station from 4:00 p.m.-7:00 p.m.
